2. The terms and conditions of this sanction are mentioned below:

- i) The visit will commence on 12 May 2018 or from the date of departure;

- iii) They will draw their usual pay and allowances from Bangladesh in local currency;
- iv) On return from abroad they will submit a report to the Secretary, Ministry of Labour and Employment on the activities of the Study Tour;
- v) They will leave Denmark for Dhaka on 20 May 2018 or on any date nearby;
- vi) All the expenses will be borne by Danish Government. Economic class air ticket to and from Denmark will be borne by the Danish Government. According to the government rule the officials (**Serial No. 1 and 2**) are entitled to travel in business class. Therefore to adjust the business air ticket extra cost will be borne by the Ministry of Labour and Employment and Department of Inspection for Factories and Establishments from their regular budget as per rules and regulations.


